**Waiver Release and Covenant Not to Sue**

**This waiver must be signed before participation is allowed in any practice or race sponsored by Wasabi Paddling Club. READ CAREFULLY BEFORE SIGNING.**

I, the undersigned (please print your name) \_\_\_\_\_, hereby certify and declare that I am a participant in a paddling program or event that may require dry-land instruction and one or more periodic practices in a water craft rented and/or owned by Wasabi Paddling Club ("Wasabi"). In consideration for the privilege of use of the water craft for paddling activities, I do hereby personally, without reservation, waive, release, acquit, and forever discharge the water craft owner(s), Wasabi and its officers, agents, and employees, and any club or event sponsor, including (please print organization/ company name) \_\_\_\_\_, from any and all suits, claims, demands, or assertions of liability, injury to incorporeal interest, or other like damages occasioned by, arising from, or in any way connected with my participation in the said program or event and I do personally covenant that no action of law or suit in equity shall ever be brought against the water craft owners, Wasabi or any of its officers, agents or employees, any club or event sponsors, or the owner of the premises upon which the activities of the program or event are to be conducted on account of any matter herein above set forth.

I further declare that I am aware of the activity contemplated and of the hazards connected therewith. I understand the necessity for close supervision of the activities of the program or event, and I authorize Wasabi, through its officers, agents and employees, as well as the water craft owner(s) and the club or event sponsors who may be in charge from time to time to direct and control my activities where necessary for my protection, and for the protection of all participants in this activity.

I further authorize the person in charge to secure any necessary emergency medical services for me. I agree to pay for such services, and to hold the water craft owner(s), Wasabi and its officers, agents, and employees, and any club or event sponsor harmless therefrom.

The provisions of this instrument shall be binding on my heirs, agents, successors, and assigns.
